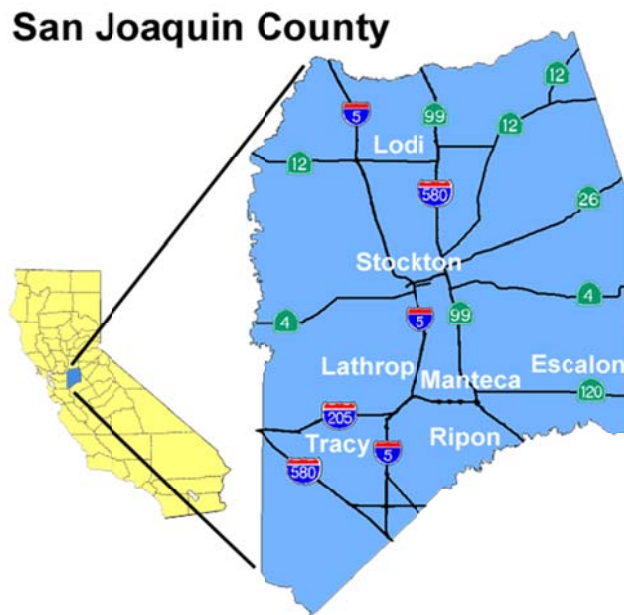

San Joaquin Facts

- San Joaquin County was one of the original counties at the time of California's acceptance into the Union in 1850.
- The county was named after the San Joaquin River, which runs through the county.

Location

- San Joaquin County is located in northern California, seventy-five miles east of San Francisco, fifty miles south of Sacramento, and seventy-five miles from the Sierra Nevada Mountains.
- It consists of seven cities; Escalon, Lathrop, Lodi, Manteca, Ripon, Stockton, and Tracy. San Joaquin County offers some of the finest opportunities in the state in boating, fishing, camping, history-gathering, or just plain fun in the sun. Each city, as well as the unincorporated county areas, offers a unique opportunity to enjoy California's beauty, nature, music, arts, and culture.
- The City of Stockton is the county seat.



Land Size and Environment

- The County size is 1,391.32 square miles ^[1] or approximately 896,000 acres.
- 2.5% of the county is occupied by water. ^[2]

Agriculture

- The County remains the 7th largest agricultural producing county in California, with a total gross value of agricultural production at \$2.87 billion (2012)* ^[3].
- San Joaquin County is 7th largest export market for agricultural goods in the nation, and total agricultural exports reached a total of \$616.0 million in 2014. ^[4]

Language

- Roughly 39.9% of residents five years or older within San Joaquin County speak a language other than English at home. The Census Bureau identifies 39 individual languages or language groups spoken within the County. The top three languages spoken, in order from most to least, are: Spanish (22.1%), Tagalog (2.6%), and Mon-Khmer/Cambodian (1.4%).^[8]
- 18.2% of San Joaquin County residents five years or older speak English less than “very well” as defined by the Census Bureau.
